#### Administrator's Report



I must admit when compiling our June Newsletter, I never envisaged that the Covid 19 fallout would dominate my December Report.

I am pleased to say that apart from the cancellation of our planned September seminar we have more or less managed to get back on track.

Both General Council and the Education Board managed, via "GoTo Meetings", to hold all their scheduled meetings and even managed to squeeze in a couple of extra ones. With all going well we are actively considering in future holding a proportion of our meetings on a virtual basis.

Curtesy of Go To Meetings The Executry Exam which should have happened on the 25th of March finally took place on the 28th of October. Results were very good with 22 Distinctions. On the same basis the Feeing Exam was held on the 23rd of September. Again, results held up with 15 students obtaining distinction. Normally students who complete the three modules receive their diplomas in October, of course as the classes and exams where delayed it will now be early in the New Year before these are awarded.

For the year 20/21 all classes and exams will continue to be carried out on a remote basis. The Cashroom course with 33 students commenced 2nd November and will end with the Feeing exam on the 23rd of June. Although we have managed to ensure that no classes or exams are cancelled, they will now be running at a slightly later date due to the knock-on effect from the delays experienced for year 19/20.

On behalf of the Education Board, I would like to thank all our students, lecturers, invigilators and examiners for both their commitment and flexibility demonstrated throughout the last few months. We as a Board were anxious at all times to ensure that there was no drop in our standard of course delivery/results. I do feel that with having the cooperation of all involved that this has been achieved

For the first time our AGM on 7<sup>th</sup> November was held on a virtual basis. Although the numbers signing in were slightly disappointing it was encouraging to see some newcomers. Please see a picture below. All going well our next AGM and Dinner will be held in Dundee in November 2021. On the other side of the coin, we had what must be said were exceptional numbers signing into a Seminar arranged by our Edinburgh Branch. Out of 90 invites 70+ joined in on the evening. The obvious advantage is that attendance can be opened up to other branches thus aiding CPD requirements.

With some sort of gathering restrictions still likely to be in place General Council have decided to cancel our Perth 2021 Spring Seminar. However, given our relative success utilising GoToMeetings we are actively discussing the possibility of the Law Society delivering their presentation virtually over say a two-hour period. If proceeding on this basis it would once again be geared for the middle of March with the usual invitations being sent out in advance to all members.

There has been a very good return of subs/CPDs. I would just mention that any received after the 31st December will incur a £10 late fee along with a 14-day letter.

Although CPD hours will be required for 2020/21 no decision has yet been taken re the actual number. With virtual seminars being held I would urge you on an ongoing basis to record all qualifying hours. Please always make sure you use the most up to date version of the CPD form.

During November a diary was sent to all members who have asked to remain on our mailing list. Please let me know if you no longer wish to receive one.

With many members at present still working from home please ensure that I always have the benefit of your preferred mailing address. There have been instances of late where emails/mail have not reached their intended target.

Finally, I would just like to wish you all a very merry Christmas and let's all hope for a much brighter 2021.

It has been a very strange year! Since the newsletter last year, Edinburgh has had only one Seminar – back in February, a talk was given by **Austen Burns** and **Gillian Wilson** from Gillespie Macandrew LLP who addressed us on '**Making the most of IHT allowances and bands**. Austen and Gillian, both Solicitors in Gillespie Macandrew's Private Client team gave a very interesting talk on what IHT relief is available and explaining the circumstances when it comes into play which was well received by members. And we all went home as usual, expecting to return in March for another face-to-face seminar when we could shake hands, sit next to each other, see each other's faces without masks and attend our places of work on a regular basis using public transport without rubber gloves and bottles of hand sanitiser...

The ongoing COVID restrictions meant the New Student's Reception in August, the proposed afterwork CPD Seminar in September and the Graduation Ceremony in October were not able to go ahead either, but lectures and exams have resumed online. We are also pleased to welcome Catherine Waugh as a new member to the Edinburgh Branch and look forward to being able to welcome her face to face soon!

Alex has kindly agreed to join our bank of speakers and share his slides with those who attended.

The committee of the Edinburgh Branch hope to have another online seminar on 20th January 2021 and anticipate that this will be opened up nationally so watch this space!
